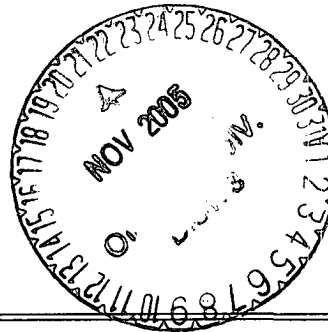

No cement or pressure testing required on 5 1/2" liner.**
