Pit to be closed within 60 days following completion and in accordance with NMOCD guidelines and Williams procedures.

Drilling/Completion pit is located approximately 50 to 75 feet from well head. Pit multi-use drilling and completion to avoid additional site disturbance and pit will be considered out of service once production tubing set.
