RIH w/8 jts 5-1/2" 15.5# J-55 pre-perf'd liner and set @ 3700'. TOL @ 3353 (38' overlap). Milled out perf plugs. Perf's from 3397' - 3483' and 3569 - 3612' Approx. 258 total holes (2 spf). TOH.
