XTO Energy Inc. proposes to squeeze cement in the following manner: Squeeze 4-1/2" production casing leak which has been isolated at approx 3185'-3308' by setting a CIBP @ +/- 3383' and a cement retainer @ +/- 3100'. Sting into cement retainer with 2-3/8" tbg, establish injection rate & pump 100 sx cmt into casing leak. Allow cement to set overnight and drill out and pressure test casing. Spoke w/Matt Halbert w/BLM @ 3 pm, 11/21/05 & Charlie Perrin @ 3 pm, 11/21/05 for permission to proceed with work. Permission granted to proceed.
