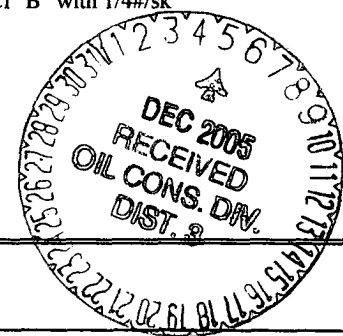
Permitted depth on original APD (120')

09/26/05 spud 12-1/4" surface hole. Drilled to 132'KB. Ran 3 jts (124.34') of 7", 20#, J-55, ST&C new LS casing and set casing at 130'KB. Cemented with 75sx (88.5 cu. ft.) of Cl "B", 3% CaCl₂ and 1/4 #/sk celloflake. Circulated 6 bbls of good cement to surface.

09/27/05 Nipped up the BOP and pressure tested the casing and BOP to 600 psi.

09/28/05 TD hole at 1300'. Ran 34 jts (1279.79') of 4.-1/2", 10.5#, J-55, EUE 8rd casing and landed at 1285.54' KB, insert float is at 1268'KB. cemented with (206 cu.ft.) of Cl "B" 2% sodium metasilicate, 1/4#/sk celloflake. Followed by 75 sx (89 cu. ft.) of Cl "B" with 1/4#/sk celloflake. Bumped plug to 1200 psi., float held ok. Circulated 10 bbls of cement to the surface.
