Tag cement @2968'. 11/17/05 Rig up mud loggers and drill with 6 1/4" bit, open hole to 3458'. 11/20/05 Ran 5 1/2", 15.50#, J-55 LT&C liner, top @ 2968', bottom @ 3458'. No cement or pressure testing required on 5 1/2" liner.
