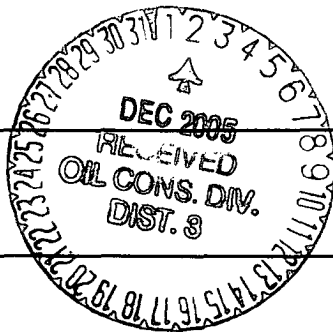

13. Describe Proposed or Completed Operations

After setting intermediate casing and drilling ahead with 6-1/4" bit reached 5071' and the hammer quit. We POOH and the well was started venting at a good rate. **Called the BLM and received verbal approval from Jim Lovato** to run a 48-hr pitot test, shut down and do a pressure build-up test. 11/27/05 Geologist and Reservoir Engineering decided to drill this as a MV only well and set TD @ 5071' (bottom of Menefee) and set the 4-1/2" casing string w/ECP @ 4550', then cement w/108 sx Premium Lite from 4550' to 7" shoe. And then have the hole from 4550' to 5071' (TD) uncemented. **Received verbal from Jim Lovato @ 12:38 pm 11/27/05.**
