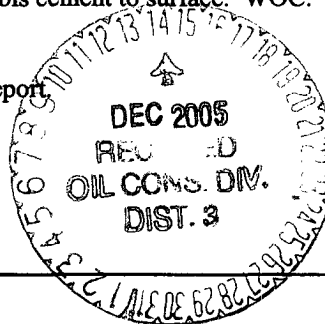

12/6/05 MIRU Mote #1. Spud 8-3/4" hole @ 0900 hrs 12/6/05. Drilled to 143'. Circ. hole. RIH w/8 jts of 7", 20# J-55 ST&C casing and set @ 140'. Pumped a preflush of 2 bbls H2O ahead of 34 sx (54 cf - 10 bbl slurry) of Type I-II Portland cement with 20% Flyash. Dropped plug and displaced w/3.6 bbls H2O. Circ. 2 bbls cement to surface. WOC. Installed WH. RD & MO.
