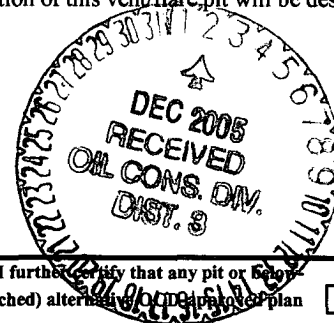

Burlington Resources anticipates closing the pit according to the Drilling / Workover Pit Closure Procedure dated August 2, 2004 on file at the NMOCD office.

On this well, a vent/flame pit may be the only pit that will be required. Under this circumstance, a portion of this vent/flame pit will be designed to manage fluids, and that portion will be lined, as per the risk ranking criteria.
