This well passed a MIT on April 5, 2005. At that time, the BLM granted a period of 6 months in which to evaluate the wellbore for possible recomple. A number of wells in this area are currently being evaluated for uphole potential, as part of a larger reservoir study. Once completed, a sundry notice will be filed either to recomple or for plugging and abandonment. It is respectfully requested that an extension of 12 months be granted, in which to complete our evaluation.
