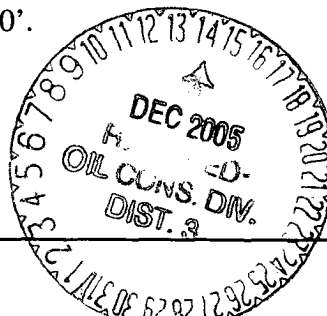

12/7/2005 MIRU Aztec #580. Spud 8-3/4" hole @ 21:15 hrs 12/7/05. Drill ahead to 145'. Circ. & condition hole w/ air mist. RIH w/ 3 jts 7", 20#, J-55 ST&C csg & set @ 140'. Pumped pre-flush of 10 bbls H2O, then pumped 11 sx (26 cf - 5 bbls slurry) Type 3 Scavenger cmnt., tailed w/ 50 sx (64 cf - 11 bbls) Type 3 cmnt. Displaced w/ 4 bbls H2O, circ. 10 bbls cmnt. to surface. WOC. NU BOP & WH. PT csg. to 600# for 30 min. TIH & tagged cmnt. @ 82'. Continue to drill ahead to 2300'.
