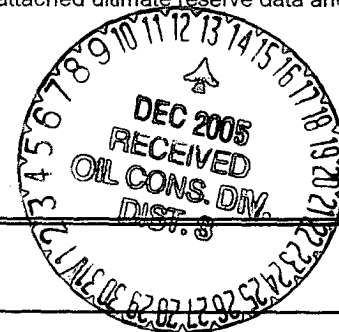

This well was commingled in the Blanco Mesaverde (72319) and Otero Chacra (82329) as per DHC-129AZ in ~~September~~ ^{October} 2000.

We propose this gas & oil allocation and believe it to be reasonably accurate. This gas allocation is based on the ratio of the average ultimate reserves of all the Chacra and Mesaverde wells in the nine sections around the subject well. Since the Chacra formation does not make any oil, all oil is allocated to the Mesaverde. See the attached ultimate reserve data and calculation sheet. Notice has been filed concurrently on form C-103 with the State.
