Drilled 12 1/4" hole to 298' on 10/19/05, set 9 jts of 9 5/8", H-40, ST&C, 32.3# casing at 290'. Cemented w/175 sx (37 bbls) "B" cement w/2% CaCl and 1/4# PSX Floseal. Circulated 15 bbls of cement to surface. Test casing to 1500 psi.

Drilled 6 1/4" hole to 3,525' on 10/21/05, set 83 jts 4 1/2", J-55, LT&C, 11.6# casing at 3,519'. Cemented lead w/500 sx (131 bbls) 50/50 POZ w/2% Gel, 2/10% Veraset, 1/10% Diacel LWL and tail w/75 sx (25 bbls) 50/50 POZ, 3% Gel, 1 4/105 Halad 9, 1/10% CFR3, 5# Gilsonite & 1/4# Flocele. No cement to surface, top of cement at 1950'. Landed 2 3/8" production tubing at 3,398'.

On 11/1/05 - 4 - 0.33" holes were shot at 1,850'. Pumped lead 195 sacks (71.7 bbls) class B neat cement, tail 25 sacks (5.1 bbls) class B neat cement. Circulated 7 bbls cement to surface.
