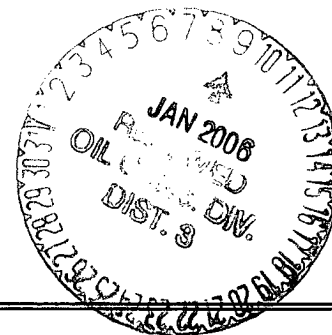

Spud 12 1/4" hole on 12/9/05. Run 8-5/8" 24# J-55 csg. Land @ 127', float collar @ 84'. Cement w/80 sx Class "B" neat w/2% CaCl2 w/1/4# celloflake/sx (106 cu ft total). Displace w/5.5 bbls water. Circulate 5 bbls cement. NU BOP. Pressure test to 800# for 30 mins, held ok.



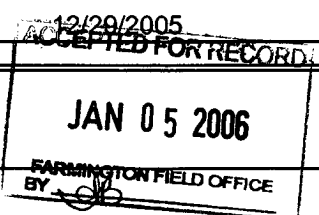
