It is intended to deepen this existing Basin Fruitland Coal well by approx. 170' to reach additional coal. The current TD is 3109' and the anticipated new TD will be approx. 3279'. We will do this by removing the tbg, then liner. RIH w/6-1/4" bit & tag TD, then deepen to 3279'. Circ. clean and then rerun liner and set @ new TD with TOL tying into the 7" casing as required. Then the well will be put back on production. A mudlogger will be present to insure Pictured Cliffs gas isn't encountered.
