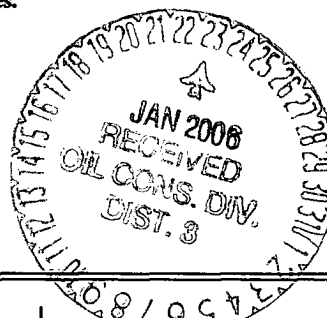

(WC) 3162.3-2 (21110)), Lance Oil & Gas Company, Inc. continues to inject produced water into this well. Since our acquisition of Richardson Operating's properties in October, 2004, these volumes were reported incorrectly on C-115 reports to the New Mexico Oil Conservation Division. These reports have been amended and resubmitted to the New Mexico Oil Conservation Division on January 10, 2006. Please advise if the records do not adequately reflect these changes.
