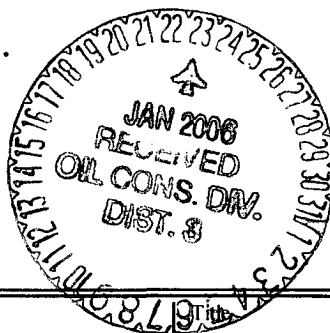

Frac'd Upper Dakota perfs fr/6330' - 6522' dwn 5-1/2" csg w/64,374 gals 70Q 25# Purgel III LT CO2 foam frac fluid (zirconium XL, 25# guar gel, 2% KCl wtr) carrying 100,300# 20/40 Ottawa frac sd & 30,300# 20/490 Super LC sand.
