1/18/06 MIRU Mote #1. Spud 12-1/4" hole @ 0900 hrs 1/18/06. Drilled to 226'. Circ. hole. RIH w/7 jts 9-5/8", 32.3# H-40 casing and set @ 223'. Pumped preflush of 4 bbls H2O ahead of 76 sx (121.5 cf - 21.64 bbl slurry) Type I-II Portland cement w/20% Flyash. Dropped plug and displaced w/7.2 bbls H2O. Didn't circulate cement to surface. 1/20/06 Installed 3/4" PVC to tag cement. Tagged cement @ 90'. Mixed and pumped 45 sx (62.55 cf - 11 bbl slurry) Neat cement to bring to surface. Circ. 1/4 bbls cement to surface. Install WH.

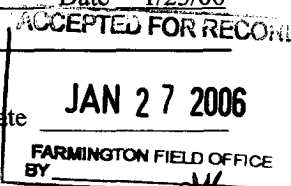
