Elm Ridge Exploration Co, LLC reached a TD of 1575' on 1-21-06. On 1-22-06, we ran 5 1/2" 15.5# J-55 casing to 1560' KB. Pumped 155 sks STD cement. Tailed in w/ 110 sks of STD cement w/ 2% CACL. Circulated cement to surface w/ 10 bbls of excess. Pressure tested well to 1500 PSI.

- Prior approval is required to make casing changes. This office has no record, written or verbal, approving a casing change for the production string. This is a violation of 43 CFR 3162.3. If such violations occur in the future, a penalty may be issued.
