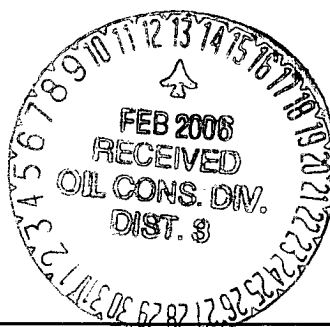

XTO Energy Inc. proposes to remediate an earthen pit acquired from Amoco Production Company in January, 1998. The earthen blow pit is located near an irrigated field adjacent to the Navajo Nation. Shallow groundwater from irrigation was seeping into the pit, requiring large volumes of water to be removed for disposal and offsite landfarming of hydrocarbon impacted soil (approx 2000 bbls wtr & 1500 yds soil). A groundwater monitoring well will be installed near the center of the former pit to assess the impact to the groundwater.
