Change 6-1/4" hole to 7-7/8" hole. Depth to be 2005'. Change casing from 4-1/2", 10.5#, K-55, ST&C to 5-1/2", 15.5#, J-55, ST&C. Change cement from 200 sx of lead & 50 sx of tail to 225 sx lead & 100 sx tail.
