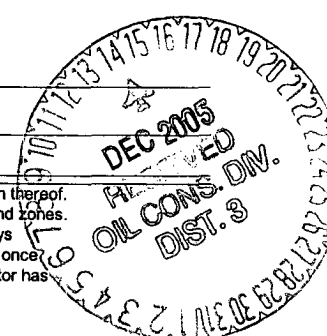

- a) restoring to a useful function
- b) temporarily abandon
- c) plug and abandon
