

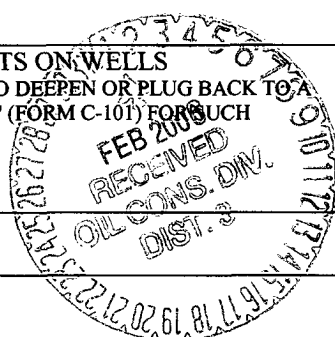

It is intended to remove the packer from the subject well and commingle the Basin Dakota (Pool Code 71599) and the Otero Chacra (Pool Code 82329). The production will be commingled according to Oil Conservation Division Order Number R11363. Allocation and methodology will be provided after the well is work is completed. Commingling will not reduce the value of the production. Bureau of Land Management has been notified in writing of this application.
