- 1) Pull tubing and run baack in hole with packer on end of tubing.
- 2) Set packer @ \pm 1195' (end of 5½ casing @ 1245', open-hole completion 1245-2081').
- 3) Pressure test casing to at least 550# for thirty minutes.

Appropriate NMOC D personnel will be notified twenty-four hours prior to testing. Appropriate permission will be obtained prior to initiating the injection.
