Circ 16 bbls cmt. Cmt'd 2nd stage w/460 sx Type III cmt w/8% gel, 1/4 pps celloflake, 2% phenoseal (11.9 ppg & 2.60 cuft/sx) followed by 100 sx type III neat cmt (14.5 ppg & 1.39 cuft/sx). Circ 31 bbls cmt to surf.
