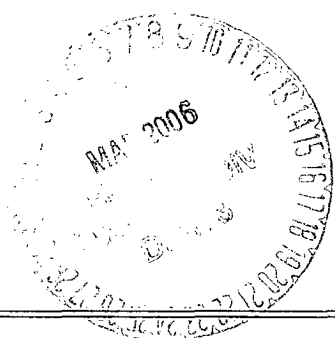

Perforations are from 3,234' - 3,445', 4 SPF, 0.55", 320 holes, 120 degree phasing. On 12/22/05 ran back in hole with 107 jts of 2 3/8" tubing J-55, 4.7#, LT&C, end of tubing set at 3,435', return well to sales on 12/23/05.
