

Cement with 250 sks Class B, 2% CaCl2, 1/4#/sk floccle (295 cu.ft.). Plug down @ 9:45 pm on 01/27/06. Circulate 5 bbls cement to surface. WOC. RD Halliburton. NU BOP. Test casing & BOP to 600 psi - ok.
