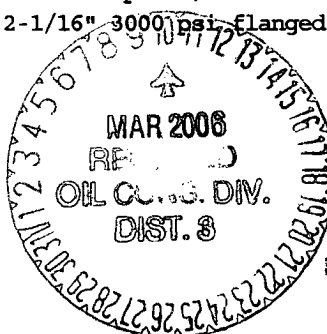

XTO Energy Inc. proposes an amended change to this program :

In lieu of a mud cross underneath the BOP's, XTO Energy proposes running two 3-1/8" 3000 psi flanged gate valves off the choke line flange on the BOP's. From that point, XTO will run a 3" heavy duty line to the manifold. On the kill line side, XTO will run a 2-1/16" 3000 psi flanged gate valve & a 2-1/16" 3000 psi flanged check valve.
