13. Describe Proposed or Completed Operations

Golden Oil returned this well to production February 17, 2006.

Work performed from 1/26/06 to 2/17/06:

MOL, RU, pull rods. Work tubing free, pull tubing, found anchor. Run casing scraper. Set RBP at 6089'. Pressure test 4.5" casing to 1000 psi, held OK. Recover RBP. Set packer at 7092' with EOT at 7250'. Treat Dk perforation with 500 gal 15% HCl, max pressure 900 psi. Treat Gallup perms down casing with 500 gal 15% HCl, on vacuum. Wait 4 hours, release packer, swab back 65 bbls. Pull packer. Clean out fill with bailer. Fish parted tubing. Land tubing. Swab well. Ran rods and pump. Land 2.375" tubing at 7257' KB with SN at 7221'; 1 joint tubing, 4' perf sub, SN then 229 joints tubing. Ran pump then 88 - 7/8" rods, and 199 - 3/4" rods.
