- 1) Pressure test 2-7/8", 6.4# casing to 600 psi.
- 2) Pump 20 bbbls water down casing to establish rate.
- 3) Bullhead w/97 sks (112 cu ft) Class G neat cement from surface down the casing.
- 4) Tag top of cement at surface.
- 5) Fill annulus with cement if necessary.
- 6) Cut wellhead and install hole marker.


