



**Pools to be Downhole Commingled:** Blanco-Mesaverde (Prorated Gas-72319) and Basin-Dakota (Prorated Gas-71599) Pools  
**Perforated Intervals (Estimated):** Basin-Dakota: 7,212'-7,436'; Blanco-Mesaverde: 4,922'-5,425'  
**Allocation Method:** Based upon the 2014 average production from eight wells offsetting the Jicarilla B No. 4F (See Attached Table), Enervest proposes to allocate production to the well as follows:


