Cement w/205 sks (241.9 cf) Variocem Cement 15.8#/gal, 1.18 yield, 5.24 gal of H2O/sk. Plug down at 15:30 hrs on 10/17/15. Circulated 16 bbls of cement to surface. Derrick McCuller (BLM) on location to witness csg and cmt operations. Rig released 10/17/15. Energen will pressure test 9.625" casing upon returning to location and will be reported on a sundry at that time. ✓
