RU slickline, try to retrieve G plug. Fished out top set of slips. TOH w/plug. plug dragged up hole for 98' & became stuck. Attempted to work free. Unsuccessful. Plug left in TBG @ 7440'. Blow down well. RU wireline, TIH w/freepoint, tagged G plug @ 7440'. Free point TBG @ 7430'. TBG free. TOH TIH & cut off TBG @ 7425'. Note: left seal assembly & 110' of pipe w/G plug in it. TOH. TIH w/scraper to 7420'. TOH. TIH w/CIBP & set @ 7400'. TOH. Note: Chris Roth w/BP spoke w/Jim Lovato w/BLM concerning fish left in hole and setting of CIBP @ 7400' in lieu of 7450' as stated initial procedure. TIH w/2-3/8" production TBG & land @ 5444'. Pressure test tubing to 500 psi. RU SL unit & run gauge ring for 2-3/8" TBG. Pull plug & set tubing stop for plunger. RD slickline unit. Service unit released @ 3:00 hrs on 11/10/2003.
