E. This exception is requested for the following reasons: 1st Flare Extension

WPX Energy requests authorization to flare the NE Chaco Com #268H due to a potential crossflow event as a result of nearby frac activity on NE CHACO COM #902H/912H. If a crossflow event on the well results in nitrogen content above Williams pipeline standards, flaring may begin as soon as 1/6/16, given approval. The well would flare for up to 30 days. Pipeline quality gas should be obtained within 30 days. A gas sample will be collected upon the confirmation of crossflow and sent to a third party for a gas analysis. The results of the gas analysis will be submitted upon receipt.
