Bridgecreek Resources (CO), LLC submits this revision to the cuttings trench closure plan submitted on 1/1/16.

A mixing pad will not be necessary and we will be able to stabilize the cuttings at a 3:1 ratio within the lined trench prior to burial. Cuttings and clean soil will be layered in a manner similar to layering of a lasagna in the trench prior to stabilization. The location of the trench will allow adequate space for a track hoe to deposit clean soil and cuttings and stabilize from all 4 sides without getting into the rig zone for future well drilling.



