The wellhead pressure on the Chacon Jicarilla D #20 has built up to 1,900 psi due to fracing operations being conducted on Energen's Chacon Jicarilla #602H. Energen would like to vent gas on the Chacon Jicarilla D #20 to a flowback tank in order to relieve this wellhead pressure. It is anticipated that the wellhead will need to be vented up to four hours daily until the wellhead pressure drops down to approximately 200 psi. The wellhead pressure will be monitored daily, and it is anticipated that it will need to be vented daily until the plugs are drilled out on the Chacon Jicarilla #602H.

A subsequent report will be submitted once these venting operations are no longer necessary.
