Elm Ridge Exploration CO LLC originally permitted this well under the Otero Chacra and the South Blanco PC formations. We completed this well in October of 2006. We perforated this well from 2904' - 2938' (South Blanco PC formation). We intended to perforate in the Otero Chacra, but have not done so, as of yet. Since first delivery, on October 23rd, 2006, this well has only produced from the South Blanco Pictured Cliffs[72439] formation. Upon further review from the OCD, this well has previously been reported under the Bisti Pictured Cliffs[97073]. The OCD will need to correct the formation and Elm Ridge will revise all production dating back to 2006 under the correct pool code of 72439.
