RU Halliburton. Tested pumps & lined to 5500psi, pumped 10bbls H2O spacer, 40bbls tuned spacer @ 11.5PPG, Lead 550sx (133.2bbls) @ 13.3 PPG, YD 1.36 Extendacem cement. Washed pump lines, drop dart. Displaced w/ 140bbls KCL water (inhibited), @ 22:30 4/4/16 plug bumped @ 1600psi, pressured up to 2500psi, floats held-1bbl back on bleed off. Sting out of liner hanger, roll hole, circulated 20bbls cement to surface. PSI tested liner top to 1500psi for 30minutes-Good test. RD Halliburton & lay down baker cement head.

RIH w/ Tieback string - Ran 119jts of 4.5", 11.6# LT&C, P-110 CSG. Landed and tested mandrel (antelope services) to 1500psi - Good test and charted. Rig released @ 10:00hrs on 4/5/16.
