NU BOPE. S/M & install tested plug, press test against blind rams 250 low 2000# high-good test and recorded on antelope services chart. Pulled test plug & tested surface casing against blind rams 1500psi for 30mins-Good test and recorded on antelope service chart.

4/6/16-4/14/16-Drilling ahead 8-3/4" Intermediate Hole. Work tight hole @ 2511'. TIH, screw into fish @ 1356'. Circ., CO and jar on fish @ 2193'. Continue to work pipe, wash over and jar on fish @ 1874'. Circulate, POOH, PU work string & over shot. TIH, fish free point attempt back off @ 2239'. TIH, w/ wash pipe & wash over fish @ 2237'-2452'. Circulate & condition. Continue to jar on fish and TOO, w/ fish. Fish released.

4/15/16-Wash and ream. Continue to Drill ahead 8-3/4" intermediate hole.

4/16/16-TD 8-3/4" intermediate hole @ 5575'. (TVD 4950'). Run 128jts 7", 23#, J-55, LT&C csg. Landed @ 5564', FC @ 5519'. Circulate & condition. Lande mandrell & test 2000psi- tested good.

4/17/16-PJSM, rigged up Halliburton. Tested pump lines 4500psi- Good test. Pumped 20bbls mud flush spacer 20bbls chem wash, 10bbls FW, 177.1bbls, 510sx Halcem lead 12.3#, 1.98yld, 92.61bbls, 400sx Varicem 13.5#, 1.3yld. Dropped plug & displaced 217bbls (mud, H2O) Bumped plu w/ 2300psi, 1600psi prior @ 02:25am on 4/17/16. Floats held. 2.0bbls back to truck, 40bbls cement to surface. WOC.
