1. MIRU. TOH and lay down tubing.
2. Set CIBP at 4249'. Test casing to 3000 psi.
3. Selectively perforate Fruitland coal and fracture treat.
4. Flow back frac. TIH and clean out to PBTD with air mist.
5. Run 2 3/8" tubing. Run pump and rods. Install pumping unit and return to production.

Note: A amended well location plat with the dedicated acreage is attached.
