On April 25th and 26th, the bottom portion of this well was abandoned in accordance with approved NOI - ID 334027. Onsite were John Hegstrom (BLM) and Brandon Powell (NMOCD). Per the CBL there is good cement covering all potential water intervals with bond to depth of ~262'. The CBL was sent to Jack Savage on the 26th via email.

The TOC has prompted a revision in the final abandonment of the subject well as follows:

Rig up a workover rig  
Conduct free-point of the 2-7/8" casing  
Cut casing at ~200'-250'  
Pull casing and lay down  
Run cement tubing to ~250'
