
BIYA Operators Inc. respectfully requests permission to build a tank battery at the HGU 197 Well. BIYA Operators would like to eliminate the long flow line from the HGU 197 to the B battery manifold and to the HGU A battery in section 34. This will reduce the possibility of line leaks. This Tank battery will be built per our SPCC requirements and we will use Best Management Practices. We will lay a layer of base at the site, laydown a 30 mil liner on base. A layer of gravel will be laid on top of liner. We will set a 300 barrel oil tank. Either a steel containment berm or an earthen containment berm will be constructed around the tank and the berm will be built to hold 125% of the volume of the 300 Bbl oil tank.
