Therefore, the Lybrook H04-2208 01H well will now be a part of the Bettonnie Tsosie Wash Unit. We are submitting this sundry and corresponding survey plat package to change the well name from the Lybrook H04-2208 01H to the Bettonnie Tsosie Unit 601H.






