On 6/5/2003 work commenced to Plug and Abandon the subject well.  
Rigged up and removed existing tubing and packer from wellbore  
Set cement retainer at 2850'  
Cemented perforations below retainer with 100 sx (21 bbls) Class "B" neat cement  
Run CBL on 5-1/2" casing and determine TOC at 310'  
Shot squeeze holes at 300' and circulate behind pipe up braidenhead  
Cemented through squeeze holes with 216 sx (37 bbls) 50/50 Poz w/ 2% Gel, 0.1% CFR-3, 0.1% HR-5 leaving TOC pipe at 1120'.  
Pumped 108 sx (18 bbls) same slurry into casing leaving TOC inside pipe at 300'  
Pumped 100 sx (21 bbls) 50/50 Poz w/ 2% Gel and 1/4# per sack flocele to fill casing. Pressured up and circulated 2 bbls cement up braidenhead  
Install P&A marker and remove all equipment from location.  
Work was completed on 6/13/2003.
