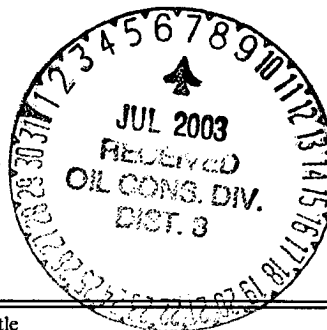

Pumped a preflush of 20 bbls FW w/dye in last 10 bbls. Pumped Lead - 475 sx (1368 cf - 244 bbl slurry) STD, 3% Econolite, 10#/sx pheno-seal. Tail - pumped 100 sx (133 cf - 24 bbl slurry) STD 50/50 POZ w/2% gel, 6#/sx Pheno-seal. Released plug & displaced w/155 bbls FW. Plug down @ 2315 hrs 6/22/03. Circ. 40 bbls good cement to surface. WOC. ND BOP, set slips and cut off casing. NU WH & BOP, PT casing to 1500 psi for 30 minutes. Good test.
