
Reason/Background for Job

The proposed work is to remove the bridge plug and produce all perforation intervals together. Depending on the well's performance, wellhead compression and artificial lift may be installed.

Basic job procedure

1. Pull rods and tubing.
2. TIH and mill bride plug at 5389'.
3. Cleanout well to PBSD of 5813'.
4. RIH with production tbg and land tubing @ +/- 5,000' – 5,500'.
EOT depth will be dependent on success of cleanout.
5. Return well to production.
Depending on performance, wellhead compression and/or plunger lift may be installed.
