Encana Oil & Gas (USA) Inc. (Encana) plans to remove the cellar ring and cut the conductor pipe approximately 6-feet below grade. Approximately 3-yards of NMDOT spec flow fill concrete, which contains 50 lbs of cement per cubic yard at 50-150 PSI, will be utilized to fill the remainder of the conductor pipe to the surface prior to the reclamation of the well pad. Encana will adhere to the specifications contemplated in the Reclamation Plan submitted as Appendix A in the SUPO, provided in the APD submitted to the BLM on March 21, 2014.
