HPOC, LLC hereby requests long-term shut-in status for the subject well due to continuing low oil prices.

At current prices, HPOC loses about \$20,000 per month to produce this well. Our high-volume lift operation works well at higher oil prices. We have 4 producers in our Entrada program capable of making about 70 BOPD. These wells are not stripper producers. We need about \$60 per barrel WTI oil price to break even at our oil cuts in the 1% to 2% range. There is a lot of future royalty to be paid to ONRR and production tax to be paid to the State of NM when higher oil prices return.
