During reclamation work pipeline in the length of 30 feet was buried on pad 24" to 40" deep.  
During the week of May 23rd, 2016 BLM Inspector Randy McKee met Vance Hixon, BP Construction Personnel on location and verbally approved the reclamation work including the buried pipe.
