Pre-flush w/ 500 gal of 2% KCL Water @ 1.5 bpm & 1140 psi, followed w/ 100 gal of Paragon 100E Solvent @ 1 bpm & 760 psi, acidize w/ 1,900 gal of 15% HCL Acid @ 1.8 bpm & 1270 psi, flush w/ 1,976 gal of 2% KCL Water @ 2.4 bpm & 1335 psi. (107 bbls total pumped)
